## Friday, 11 January, 2019 - 1830

Elizabeth Shea, Curator of Mollusks at the Delaware Museum of Natural History will talk to us about "Research at Sea - Understanding Marine Life in the North Atlantic."

Liz will talk about her numerous trips aboard NOAA

and other research vessels, the technology available today for exploring the depths of the ocean, and some of her personal research with squid and other mollusks. She'll also discuss the efforts at the Delaware Museum to focus research on Delaware's inland rivers and bays.

Dr. Shea joined the Collections and Research division as Curator of Mollusks in 2006. She is interested in all aspects of cephalopod biology, especially their ecology, taxonomy and systematics. As a graduate student, she studied the early life history of oceanic squids. Since her post-doc, she has shifted focus to understanding the cephalopod biodiversity of deep sea canyons and seamounts. She has worked with Canada's Bedford Institute of Oceanography's Ecosystems Research Division to explore and collect specimens from the Gully Marine Protected Area, and is currently participating in NOAA's Deep Sea Coral Expeditions.



In late August 2016, Dr. Shea took part in an expedition studying the Carolina Canyons off the coast of North Carolina through NOAA. She was featured in their "Before they were scientists" series and wrote "Cephalopods: Photobombing Deep-sea Corals" for the expedition's website. For Science Friday's Cephalopod week in 2017, Dr. Shea was interviewed for the short film, The Giant Squid's Biggest Mystery.

# Educational Department

## The Evolving USPS Education Program

National Education Officer Craig Fraser, SN wrote a column in the current issue of <u>The Ensign</u> about sweeping changes to the education program. "Change is always hard, but we must embrace change to be the elite boating organization we were, are and always will be. We in the Education Department have been moving through the winds of change and will continue holding our course pointed into the future," he wrote.



The elements of plan to upgrade the program were intriguing, but also disappointing. Change seems to mean repackage and make it more accessible to the public without directly involving the squadrons.

The Piloting course is now Marine Navigation; Advanced Piloting is now Advanced Marine Navigation; Junior Navigation is now Offshore Navigation; and the final advanced grade is now Celestial Navigation. However a review of the Education Department pages on the National Website reveals that while the names have changed, the content remains the same. The content change will come over time but no timetable is offered. Seamanship was changed this past fall into a seminar based curriculum, and the pilot period is over and comments from squadrons using that format will be reviewed for possible refinement of the course in 2019. Course materials are available as e-books, so the students can print them or view them on a reader.

The Piloting course replacement will also be a seminar based course that will focus on electronic navigation. Students will be able to study the seminar guides on their own or with an instructor and may take them at will or as part of structured class schedule. Another indicator of the course for the future is a new website for the America's Boating Club marketing strategy. It is easy to navigate and user friendly with links to a lot of useful information. A page entitled "Dive Deep with Courses" describes the content of the advanced and elective grades. On that page the Marine Navigation courses are described to give you the skills you need to get you where you're going using charts and marine electronics as well as a knowledge of wind, currents and tides.

## The Evolving USPS Education Program

Offshore Navigation and Celestial Navigation are a must for oceangoing captains, teaching you planning and monitoring your voyage using modern marine electronics and how celestial observations can help you estimate your vessel's position with confidence.

The Marine Electronics group has been expanded once again with a new component, "Radar for Boaters." The latest addition is now available on-line and as a printed seminar book. On the matter of on-line seminars, there are now nine available directly from this new website, most for \$30 each.



As this is a public access site introducing United States Power Squadrons as America's Boating Club, all courses are available to the public as well as members. Discounts are given to members. The is also a link to the University of Western Florida continuing education program to register for on-line narrated versions of classroom PowerPoint presentations of advanced and elective grade on-line courses and seminars. However when I checked the site in mid-December, no classes were available.

All of these new developments are welcome for making our organization more accessible to the boating public and long overdue for recognizing modern boating. But the important words are "long overdue." And yet they are still not ready for implementation. The fact that the America's Boating Club theme has been out for almost a year suggests people might be following the links and finding the promise is unfulfilled.

Of a special concern to me is the declining and less involved membership of most squadrons are not able to deliver this product which is so glowingly promoted. When the squadrons are unable to offer the classes promised or the hands-on experience of the several on-the-water-training initiatives, member recruitment is not helped.




# Boating Safety News

### COLREGS 38d

The International Rules were formalized in Convention on the International Regulations for Preventing Collisions at Sea, 1972, and became effective on 15 July, 1977. The Rules (commonly called 72 COLREGS) are part of the Convention, and vessels flying the flags of states ratifying the treaty are bound to the Rules. The United States has ratified this treaty and all United States flag vessels must adhere to these Rules where applicable. President Gerald R. Ford proclaimed 72 COLREGS and the Congress adopted them as the International Navigational Rules Act of 1977.



While we may not know the Rule number for the "danger signal" (#34d), I assume most of us correctly interpret five short and rapid blasts on the ship horn or whistle as pending collision or other danger. Rule 34d states when vessels in sight of one another are approaching each other and from any cause either vessel fails to understand the intentions or actions of the other, or is in doubt whether sufficient action is being taken by the other to avoid collision, the vessel in doubt shall immediately indicate such doubt by giving at least five short and rapid blasts on the whistle. Assuming the vessel in doubt is the




stand on vessel it maintains course and speed.

After time to determine the other vessel's action, if the other vessel does not appear to be taking sufficient action to give way or avoid collision and we are still are in doubt Rule (7a) advises to consider that risk of collision exits.

We are to determine by all possible means that collision is possible (not just likely). For example, courses and speeds steady and relative bearings remain unchanging.

Rule 8 (e) clearly states if necessary to avoid collision or al-

low more time to assess the situation the vessel shall slacken her speed or take all way off by stopping and reversing her means of propulsion.

"If necessary" is highly subjective and perhaps very difficult to assess the situation until after the fact. If there is a collision after sounding five short blasts and sufficient action is not taken to avoid collision one may be considered at fault.

Hopefully this will give a better understanding of how to proceed when in doubt of an approaching vessel and its actions. Rule 8 (e) clearly states if necessary to avoid collision or allow more time to assess the situation the vessel shall slacken her speed or take all way off by stopping and reversing her means of propulsion.



## In Memoriam

WSPS Member **Eileen M. Malin**, P, age 62, passed away suddenly on 22 September. Eileen and husband Jim sought out WSPS for some "formal" boating education some 10 years ago upon acquiring a new 34' powerboat (the *St. Somewhere*).

Eileen was an ardent outdoor person as reflected by her undergraduate and graduate pursuits in agricultural related education. The state of Wyoming became the beneficiary of both her talents and expertise. Personal involvement in the raising and breeding of horses, cattle and sheep ranching, hunting, virtually any and all things relating to the "outdoors" were active interests for the balance of her life.

Returning to the East Coast from the West, she immersed herself in the rearing of three active children (not to mention each of their respective activities), maintaining the Malin home, gardening, involvement in the family business, and the all too necessary attention required for maintaining an aging extended family.

The Malin's have since day one maintained association with WSPS as not only members, but active supporters in our advertising programs.


